**NOW THEREFORE**, in consideration of the mutual covenants and agreements herein contained, the parties hereto do hereby agree as follows:

- 7. LESSEE is entitled to one (1) space within a building located at BONANZAVILLE for the purposes of storage of a boat, car, motorcycle, or small camper, or other vehicle deemed acceptable by BONANZAVILLE, being accepted October 15<sup>th</sup> through 19<sup>th</sup>, 2025 (7:00 am. – 5:00 pm. W-F, 10 am to 5pm Saturday and 12pm-5pm Sunday) and removed April 15<sup>th</sup> through 19<sup>th</sup>, 2026 (same hours as above.) For such storage space, LESSEE shall pay BONANZAVILLE the sum of \$275 per space/ \$125 for motorcycle only. If the vehicle, boat, pontoon, and/or small camper to be stored is longer than 20 feet, an additional fee of \$20/running foot will be assessed. We can no longer accept (those not stored with us in the past) large RV motor homes due to space restrictions.
- 8. As the LESSEE and owner of the vehicle, you will determine whether the battery should be disconnected. Our staff can assist you in the disconnect but only upon your approval/request. If any damage occurs by such action, LESSEE is responsible for all damage to the vehicle.
- 1. The space(s) assigned to LESSEE will be determined by Bonanzaville staff.
- 2. The unit to be stored is described as follows:

- 9. **Units shall be removed from BONANZAVILLE: April 15<sup>th</sup>-19<sup>th</sup>, 2026, weather permitting, between the hours of 7:00 am.-5:00 pm M-F, 10am-5pm Saturday or 12pm – 5pm Sunday.** Any stored unit which is not removed from BONANZAVILLE by April 20<sup>th</sup>, 2026 (5:00 p.m.) shall be subject to an additional storage charge of \$10.00 per day.
- 5. If the stored unit above is lost or damaged through theft, fire, or act of God, BONANAZAVILLE/Cass County Historical Society and Cass County, North Dakota, shall not be liable to LESSEE for such loss or damage. LESSEE is specifically informed that BONANZAVILLE does not have property damage insurance covering said storage unit and that LESSEE should protect said property with sufficient property damage insurance to cover any loss for any reason suffered by LESSEE while the unit is in storage at BONANZAVILLE.
